Special Collections Reproduction of Materials Request Form

Permission for the reproduction of items from collections in the Congressional and Political Research Center, University Archives, or the U.S. Grant Association must be obtained by the researcher from a Research Center staff member.

Reproduction of materials will be permitted when the condition of the documents allows and in the absence of specific restrictions on the collection. Photocopies are provided for the use in the private study, scholarship, or research of the applicant only. The researcher assumes the responsibility to obtain permission to publish from all materials.

All photocopying of items from the Research Center collections is done by a Research Center staff member after permission to copy has been given. Request for copying will be filled as staff time permits.

The charge for photocopying materials out of collections is \$.20 per exposure and all other materials are \$.10 per exposure. For mail and telephone orders the minimum shipping and handling charge is \$5.00.

Under certain conditions, items may be scanned for research use; inquiries and cost are handled on a case-by-case basis by the Digital Preservation and Access Unit. Videotape or film reproduction is permitted in certain cases; a handling fee of \$5.00 in advance is required; actual charges will be determined by the University Television Center or other vendors.

The following biographical citation is recommended for Research Center materials: identification of item, name of collection, folder number or title, and container number, Congressional and Political Research Center, University Archives, or U.S. Grant Association, Mississippi State University Libraries, Mississippi State University.

COPYRIGHT RESTRICTIONS

The copyright law of the United States (Title 17, U.S. Code) governs the making of photocopies or other reproductions of copyrighted materials. The researcher assumes the responsibility to obtain permission to publish from manuscripts and published works.

Under certain conditions, specified in the law, libraries and archives are authorized to furnish a photocopy or other reproduction. One of these specific conditions is that the photocopy or reproduction is not to be "used for any purpose other than private study, scholarship, or research."
