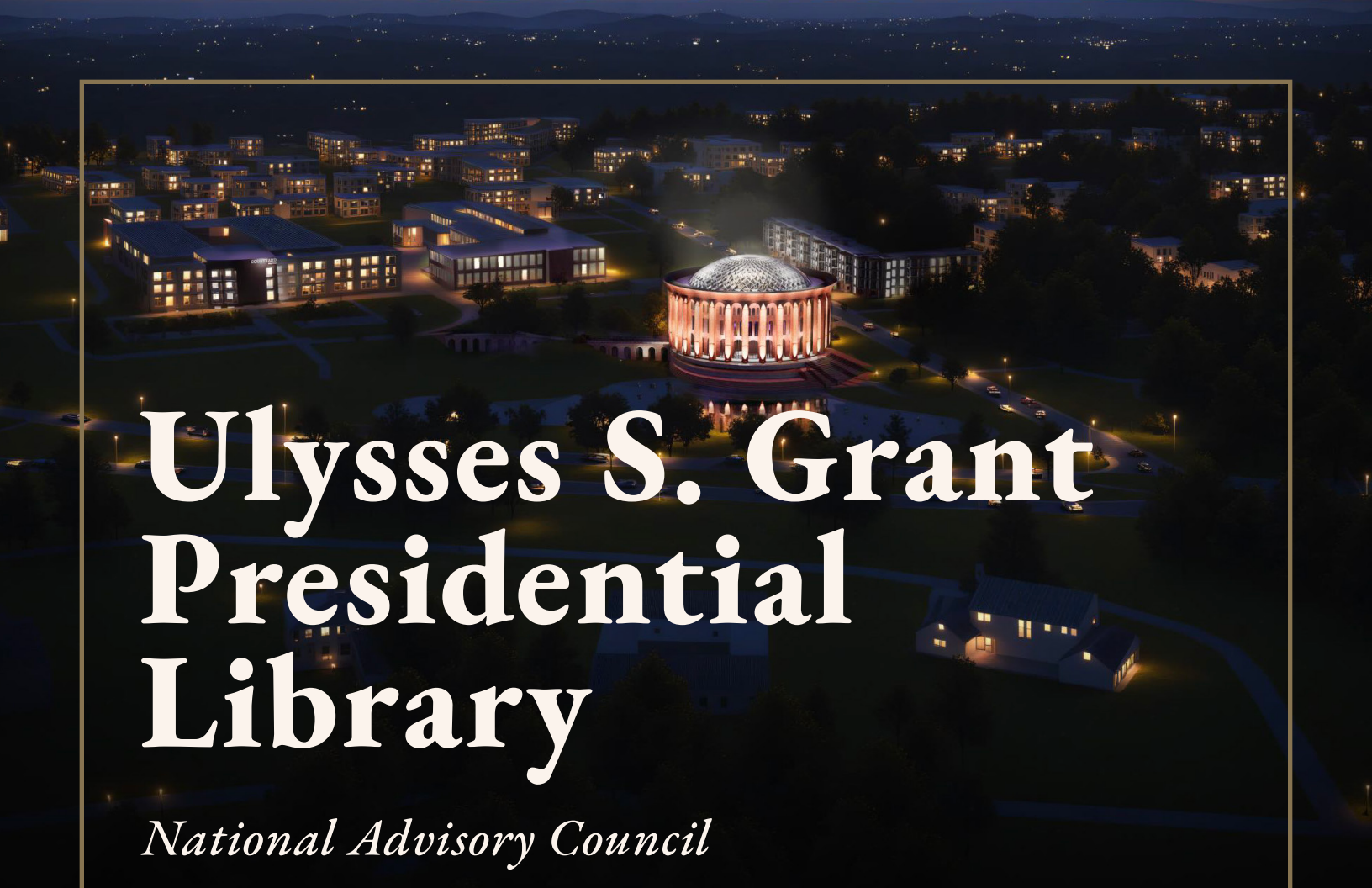




Ulysses S. Grant Presidential Library

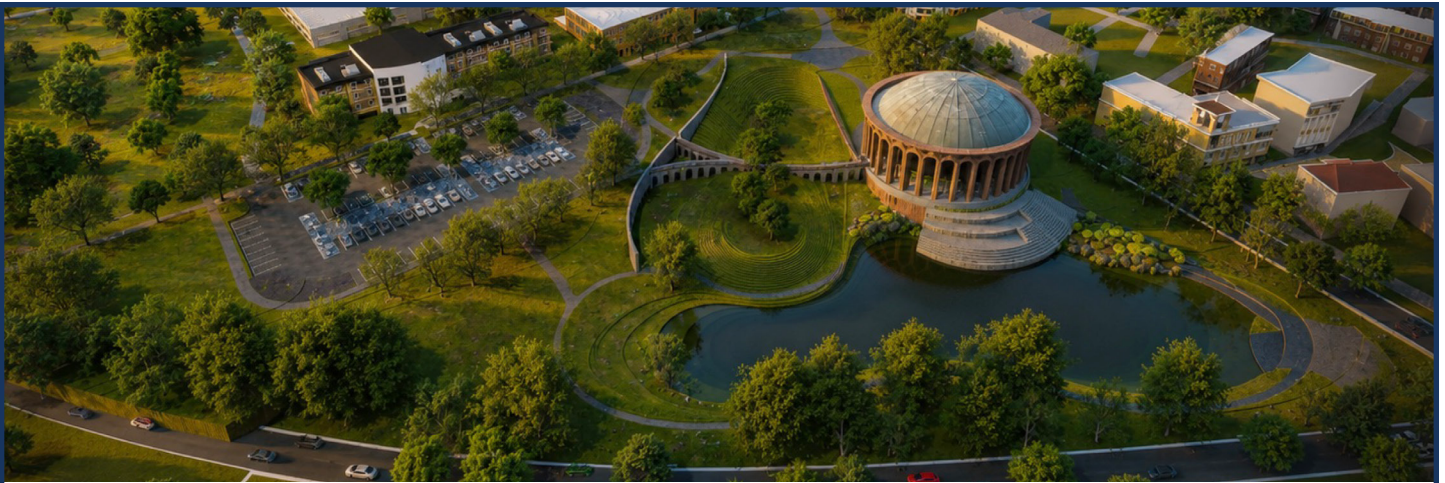
The National Advisory Council

Why Ulysses S. Grant – and Why Now?

Ulysses S. Grant was the first Republican President to serve two full terms and the indispensable military leader who secured Union victory in the Civil War. President Abraham Lincoln captured Grant's resolve simply and powerfully: "I can't spare this man—he fights."

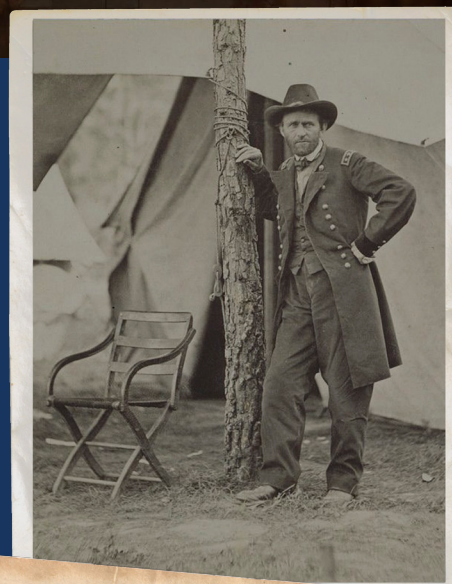
Yet Grant's legacy extends far beyond the battlefield. As President, he governed with humility, moral clarity, and determination—using the authority of the federal government to defend civil rights and enforce Reconstruction despite fierce opposition. His values—integrity, perseverance, humility, and courage in service—are urgently relevant today, as the nation again reflects on the meaning of leadership and responsibility.
